No P.O. Box # on return shipping label- only street addresses will be accepted. Please use bubble wrap or foam rubber and rubber bands- no tape or peanuts. *If you wish to have a receipt of delivery, please enclose a self-addressed stamped postcard.*

MEDIA: Open to **ALL** Mediums: 2D, 3D, written and music

RULES:

1. All entries must have SPORTS as the theme
2. Enter up to **5 pieces** per artist. Go to <http://www.academyframesco.com/artist-submission-guidelines/> for hanging guidelines.
3. All entries must be original works.
4. No size restrictions.
5. All work must be ready for **hanging with wire** and screw eyes or the like and clean. **No sawtooth hangers**. Go to <http://www.academyframesco.com/artist-submission-guidelines/> for hanging guidelines.
6. All work must be for sale and is subject to a **30% Gallery commission**.

LIABILITY: All entries will be handled with care. In the event that consigned property is lost, stolen, destroyed, damaged, or unaccounted for due to any cause, known or unknown (hereinafter these terms referred to collectively as "lost"), while consigned to AAFC:

The property, or each item, so lost shall be considered as having been sold, and AAFC shall pay unto Artist the amount agreed herein as if the lost property, or each item lost, had been sold, 70% of said amount shall be owed by AAFC to Artist. Such amount shall be due 30 days following the loss of the property.
